# **Pay Code Changes Reference Guide**



With the implementation of myPay, the entering/management of earnings and deductions will now be completed through myPay MSS or Kronos / ABI. Please review all sections to ensure you are aware of the revised procedures moving forward.

#### PLEASE NOTE:

- All **recurring** scheduled earnings and deductions (which are to be paid or deducted each pay) have transitioned to myPay.
- All one-time adjustments are entered in Kronos/ABI as necessary by the manager.
- This guide includes a section for codes that will be managed in myPay, and separate section for codes that must be entered in Kronos / ABI.
- Earnings and deductions that are already in place will carry over into myPay in January (<u>managers will NOT have to set them up again</u>). It is still the responsibility of the manager to review and ensure all earnings and deductions are correctly setup and verified in myPay on the employee's master record.

## One-Time Adjustment Earnings and Deduction Codes to be entered in Kronos or ABI (starting January 2, 2019):
